- The Purchaser agrees to follow the equipment manufacturer's recommendation for maintenance of the propane engine or conversion equipment.
- The Purchaser agrees that the equipment for which an incentive is provided must remain in use in the service area no less than three years from the date the equipment is purchased.
- This incentive cannot be used in conjunction with any other incentive.
- Purchaser must complete the pre-incentive and the post-incentive survey. The data will be used by the propane industry for but not limited to the following: industry reports, articles, and case studies.
